**While Fukushima continues to leak radioactivity into the environment, over five years after the earthquake and tsunami that destroyed the reactors, the United Nations continues to play the Resolution Game.**

**The UN General Assembly’s First Committee voted on a Resolution\* about beginning negotiations in 2017 to finally outlaw nuclear weapons. 123 Nations voted for the Resolution. Japan joined the “nuclear powers” and voted *against* the Resolution.**

**At the same time, the UN’s Fourth Committee voted to continue to study radiation injuries, but barely mentioned Fukushima and basically denied any problem; this Resolution was sponsored *by* Japan.\*\***

**It is indeed regrettable that Japan, the world’s sole victim of atomic bombings, should have voted against the UN resolution of 28 October, a landmark resolution to launch negotiations in 2017 on a treaty outlawing nuclear weapons.**

Survivors of Hiroshima and Nagasaki have naturally expressed their anger and disappointment. Conscientious Japanese people will all agree that it is a historic mission of Japan to contribute to the accomplishment of true denuclearization, both civilian and military.

**The will of the majority of the Japanese people has once again been belittled. This makes one question the governability of Japan.**

*We are reminded of the immoral realities of the present world.*

**The preset crisis the world is confronted with is neither an economic crisis nor a monetary one. It is a crisis of civilization.** The solution requires the mobilization of human wisdom on the widest global scale. Mankind faces a change of way of life not only in Japan, but the entire world.



**The deeply-rooted cause of this crisis is the universally prevalent lack of ethics.** It is against fundamental ethics to abuse and exhaust natural resources that belong to future generations and leave behind permanently poisonous nuclear waste and enormous financial debts. It is a matter of great urgency to put an end to this civilization based on greed.

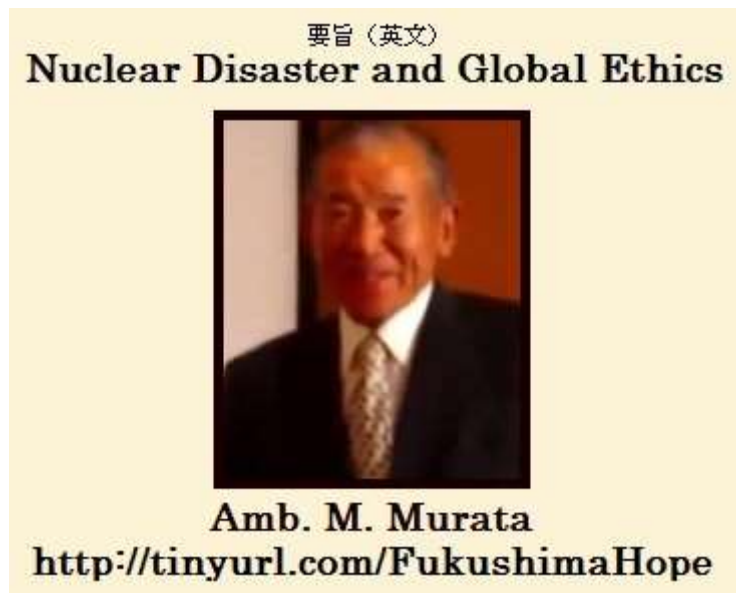

“By the terms of that draft resolution “The Effects of Atomic Radiation” (document A/C.4/71/L.5), approved without a vote, the General Assembly would support the intentions and plans of the United Nations Scientific Committee on the Effects of Atomic Radiation for the conduct of its programme of work, in particular its next periodic global surveys of radiation exposure...”

On the Scientific Committee’s 2013 report on exposure to and effects due to the nuclear accident following the 2011 great East Japan earthquake and tsunami, [the Japanese representative] said the expert group continuously reviewed new literature published since the report. While a white paper consolidating updates to the report would be formally presented in Japan in November, the findings from the 2013 report remained valid, he said, *adding that there was no evidence of thyroid cancer rates attributable to exposure*. The Scientific Committee had been focusing on outreach in order to share the report’s findings with those to whom they were of most value....” [emphasis added; Dr. Rima considers the conclusion of “no evidence” to be a false finding and unscientific result.]

**\*\*\* Murata-san has called for “honorable retreat” from the 2020 Tokyo Olympics** due to the radiation risk to the athletes.



The election on October 16 of the new Governor of Niigata Province who is opposed to the restart of nuclear reactors has shocked the National Government and the “nuclear village”. His predecessor, who was also opposed to the restart, had been obliged to “retire” for unconvincing reasons.

**This comes after the recent decision concerning the decommissioning the high-breeder reactor at Monju. This decision, if reached before the end of this year as required, allows us to foresee the *end* of nuclear reactors in Japan.**

The surprising result of the gubernatorial elections consolidates this outlook. Moreover, in view of the influence it will no doubt exert globally, it is no exaggeration to say that it will give rise to the beginning of the end of nuclear reactors.

The restart is unthinkable hereafter. The project of a new Monju reactor is doomed to failure.

**We are reminded once again that, concerning nuclear issues, the instinct of citizens excels the expertise of experts.**

The increasingly required change of the mainstream of the world that allows the presence of 440 nuclear reactors seems to have started as evidenced by the dawning of a maternal civilization. We are impressed by increasing female world leaders.

The recent revelations of scandals one after another allow us to feel the will of Heaven and Earth that does not allow immorality to last long, permits us to sustain hope for the better future.

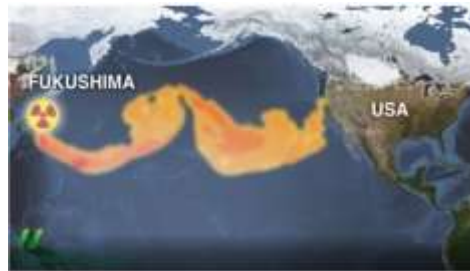
The breeder-reactor restart issue, the Toyosu fish market scandal\* and the Tokyo Olympic Games share the same cause and stem from the same root.

**Murata-san: Symptoms of a Change of Main Stream  
Attitudes about Fukushima Changing**



In previous messages<sup>4</sup>, I wrote, “The main stream of the world managed by its leadership, allowing the existence of 440 nuclear reactors, has increasingly been required to change course.”

**The Brexit has sown a seed for this change. Symptoms of this change already seem to be surfacing.**

The decision of the new British government to postpone a deal on a nuclear power station, Hinkley Point C nuclear power station, to be built by France with major Chinese investment, has shocked both of those countries. Prime Minister Theresa May had nominated eight female ministers and this has led me to expect the effects of maternal culture. The new decision is, as the New York Times writes, a potentially major step away from the policies of former Prime Minister David Cameron. Moreover, it could lead to accelerating the so-called meltdown of the nuclear industry.

Former Prime Minister Junichiro Koizumi, in an interview article published in the weekly magazine “Toyo Keizai” dated 2 August 2016, has called on Prime Minister Abe to adopt a no nuclear reactor policy, reiterating his anti-nuclear position. He referred to the establishment on 5 July 2016 of a fund to support more than 400 American sailors, victims of radiation suffered during Operation Tomodachi immediately after the 3/11 Fukushima nuclear accident. They are suing Tepco for damages. Mr. Koizumi’s humanitarian initiative is being widely supported by conscientious citizens.

The Japanese Government continues to remain quite reserved in coping with Fukushima, as is shown by the recently announced stimulus package amounting to 28.1 trillion yen to boost the Japanese economy. Fukushima is not mentioned at all. No funding for international cooperation is envisaged.

“Nikkan Gendai,” dated 28 July 2016, published an article written by Takashi Takano to the effect that Tepco has admitted the failure of the sole national project of constructing a frozen wall to prevent the release of contaminated water at Fukushima Daiichi, and that this denies the infamous “under control” assertion. The article concludes that Japan’s retreat from the Tokyo Olympics 2020 could now be realistically envisaged.

The eminent nuclear expert, Mr. Hiroaki Koide, in a message sent to me on 25 July 2016, reminded me that the *State of Nuclear Emergency Law* promulgated on 11 March 2011 remains valid, and pointed out that it verges on lunacy to hold the 2020 Tokyo Olympic Games under such circumstances.

**The supporters for retreating from the 2020 Tokyo Olympic Games in favor of Fukushima and Kumamoto are notably increasing.**

Dear Friends,

**On 1st May, I received a phone call from an outstanding nuclear expert working at the Fukushima Daiichi. He told me that a number of foreign journalists asked him recently why the Japanese Government allows the restarted Sendai nuclear reactors to continue their operations despite the unceasing earthquakes and why mass media do not take up this critical issue.**

**He himself wonders why and he said he could only reply he didn’t know. He expressed his serious fear that the containment vessels will be destroyed if an earthquake with a vertical shock of 400~500 Gal takes place at the site, causing pipes ruptures. He added that he was proposing the competent authorities to reduce the generating power by 60%, if the temporary ceasing of operations is not possible. He asked for my support.**

**Having felt the serious sense of crisis of the expert, I immediately sent a message to**



**Prime Minister Shinzo Abe, informing him of the contents of the telephone call. I reminded him of my message addressed to him of 1 March, 2016 in which I pointed out that the international community was increasingly critical of Japan for damaging the global environment by radioactive contamination, reiterating my warning that the destiny of the world is dependent on electric companies if the lessons of Fukushima are forgotten.**

**I concluded the message by stressing that the crisis confronting Japan is not that of the management of electric companies, but that of Japan as a nation. I asked for his rapid decision to halt the operations of the Sendai reactors.**

**In this message Abe, I referred to former Prime Minister Koizumi's visit to the States and its probable global impact and to the Ise-shima Summit that could not but unofficially take up the Sendai reactors issue.**

**The crisis confronting Japan calls for global attention. Please allow me to count on your understanding and support.**

Dear [Japanese Economics] Minister Mikio Hayashi,

Please allow me to send this message by FAX.

I am former Ambassador to Switzerland. While in office, I asked for staging in Japan a nuclear accident simulation. 14 years ago, I published a book entitled “Nuclear Energy and the Sickness of Japan”, which, for having foreseen the severe accident of Fukushima, has been nominated for the prestigious “Ishibashi Tanzan Prize”.

**I am pleading for the retreat from the Tokyo Olympic Games 2020, in order for Japan to concentrate maximum efforts to bring Fukushima under control.[4]**

I am sending you my message sent to Chairman Shunichi Hayashi of the Nuclear Security Authority.

**The actual situation allows us to feel the presence of the will of heaven and earth.**

We have reached the time when the top priority should be given to safeguarding the lives of the populations and to avoiding an irreparable accident to happen.

I wish to remind that I have repeatedly asked for the closing down of the Rokkasho reprocessing plant that could cause a disaster equivalent to the one emanating from 1000 nuclear reactors in the worst case. It is extremely sinful to allow the presence of such dreadful source of calamity.

**Recently, Mr. Mycle Schneider, famous nuclear expert has published an article “After the Paris-Agreement: Corporate Meltdown in the Nuclear Industry”(Asahi WebRonza). He describes lucidly the possible meltdown of the nuclear industries. The article lets us foresee the beginning of their end.**



On the other hand, Dr. Andreas Nidecker, former Director of the IPPNW (International Physicians for the Prevention of Nuclear Wars. Laureate of Nobel Peace Prize 1985. 200 thousand members from 83 countries) has sent the attached letter to Former Prime Minister Naoto Kan, proposing the postponement of the Tokyo Olympic Games until 2024 or 2028.

Wasserman continues:



“The world’s 430-plus licensed commercial nuclear plants give terrorists like ISIS the power at any time to inflict a radioactive Apocalypse that could kill millions, destroy huge parts of the Earth and devastate the global economy. Fallout from Chernobyl’s 1986 disaster has killed more than a million people. Cancer rates among children and others near Fukushima are soaring.”

Wasserman warns,

“The 2011 earthquake and tsunami took out back-up generators at Fukushima, followed by three melt-downs and four explosions. Tsunami-like flooding caused by busted dams upriver from at least three dozen U.S. reactors could replicate much of what happened at Fukushima.”

Ominously he reports,

**“And official reports on the 9/11 attacks on New York’s World Trade Center confirm that Al Quaeda also considered targeting atomic reactors.” A word to the wise should be sufficient. Pay attention to the risk posed by nuclear reactors. Take these steps:**

\* – The term “**criticality**” is used in several senses in the public discussion of nuclear reactors. Here are some key terms: **subcritical** (the reactor is losing neutrons and power), **critical** (neutron flux in balance; power production steady) and **supercritical** — when the reactor is increasing neutron output and power. A **meltdown** is when the nuclear fuel cannot not be controlled, in such cases, supercriticality leads to disaster.

The term “**re-criticality**” can refer to a nuclear system that was being shut down (in the process of



becoming subcritical) failing to continue under control and instead, becoming “hotter” and less controlled. The term can also refer to a situation in which stored fuel rods become uncontrolled, such as through the loss of cooling water, and become critical again, or even supercritical, leading to a meltdown. These are what concerns Amb. Murata in the email above.

I am sending you a copy of my letter addressed to Pope Francis.

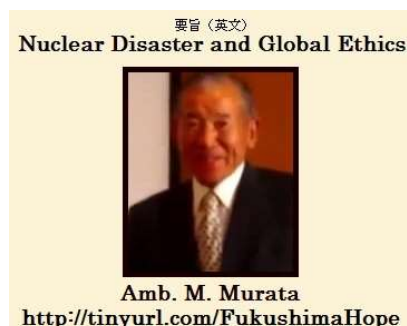
All this amply justifies the expanding plea among conscientious Japanese citizens for an honorable retreat from them for the sake of Fukushima.

**Since early April, a soaring level of radiation has been reported in some parts of Fukushima.** The weekly magazine “*Playboy*” (dated May 4 2015) carried a shocking four-page article with photos and such subtitles as: “Melting out of nuclear fuel”; “Horrors of critical chain reactions at the depths of the earth”; “Steam gushing out of Unit 3”; and “Rising of the temperature of the spent fuel pool water at Unit 2”.

This article alarms us by pointing out that the Japan Atomic Energy Agency has detected materials that suggest re-criticality at Fukushima Daiichi. It also tells us that, since the beginning of this year, we notice an increase in the amount of Cesium 134 and tritium that show the recurrence of a nuclear fission reaction.

The article warns us that if critical chain reactions at the depths of the earth happen to the debris of Fukushima Daiichi, the mass of which is extraordinarily voluminous, it will lead to a gigantic nuclear disaster of global scale.

On April 21st?Tepco announced that contaminated rain water had leaked into the sea due to the failure of the pumping system. The president of a subcontracting company contacted me to convey his anger over this incident, stressing the following points:

1. The incident is attributed to power failure, but, instead of carrying out verification every three hours as required by the rules, nothing was done for 20 hours. This is totally unpardonable. It was a telephone call he received from a relevant fisherman that helped to discover the incident.
2. Tepco lacks qualified staff to work out a solution on the site. So many blunders committed by Tepco followed by repeated apologies justify the joke that Tepco had better produce apologizing robots.
3. In the new energy policy recently announced, the cost of nuclear power generation is presented as 10.1 yen/KW, a number universally considered as a huge lie. It mocks the whole population.
4. My plea for installing dust sampling gauges to cope with internal radiation problems made immediately after the 3/11 accident remains totally ignored.

Under such circumstances, I have established contact with authorities in Fukushima Prefecture. On April 22nd, they informed me that the instruments for measuring radioactivity (77 in all) were out of order and would be replaced in due course. They told me that they have stopped publishing the radioactivity-related numbers on the homepage of the Nuclear Regulatory Authority.





On May 6th, I asked them for their comments on the above-mentioned article in “Playboy”. They do not deny the dangers pointed out by the article, but, unless they take concrete steps like removing the nuclear fuel, they think there will not be any increased dangers under present circumstances.

The foregoing should be regarded as a serious warning against an eventual severe nuclear accident. On individual, regional and national levels, serious efforts are needed to improve the situation.

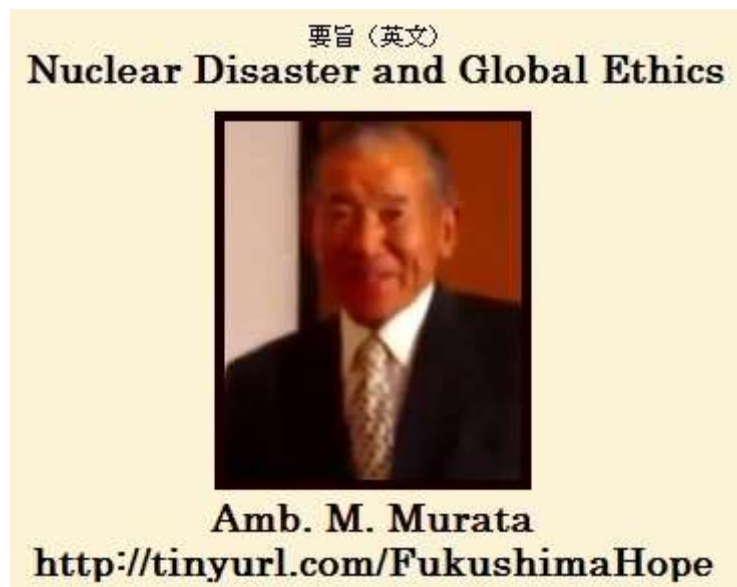
The Tokyo Olympic Games give the false impression that Fukushima is under control. The fact is, however, that the situation in Fukushima is worsening. Japan is, alas, damaging the global environment with never-ending radioactive contamination.

**Japan should devote maximum efforts to bring Fukushima under control, mobilizing human wisdom on the widest possible scale.**

## The Horrors of Fukushima

### Dolphins and the Death of the Pacific Ocean



The Fukushima accident gives the impression to the world that it has been brought under control. It is far from it. The following point of view of Dr. Norio Iriguchi, Professor Emeritus of Kumamoto University, impresses us with the potential horrors of the damaged nuclear plant. I wish to convey to you my impressions it has given me.



## 1. The point of view of Professor Iriguchi

The containment vessels of units 1, 2 and 3 are broken. The containment vessels were the last strongholds to shut radioactive materials in, but now they are now in contact with the external environment. The volume of each vessel is about 15,000 cubic meters. The temperature inside the vessels varies day and night, winter and summer, and we can presume they are breathing, so to speak, accordingly. Within the vessels, there are molten nuclear fuel rods. If the temperature rises for some reasons, radioactive materials are released into the atmosphere.

Cesium 137 contained in the containment vessels of units 1, 2 and 3 is the equivalent of 14 thousand Hiroshima atomic bombs, 7000 of which are spent nuclear fuel rods whose radioactivity will be reduced by one to one thousand in 300 years. During this period, radioactive materials will continue to be scattered bit by bit as stated above, unless a major natural disaster takes place. However, if molten nuclear fuel rods are exposed through cracks to the atmosphere due to a mega earthquake or the liquidization of the site that causes the collapse or the inclination of a nuclear reactor, Japan's landmass would become uninhabitable to a large extent.

Cesium 137 contained in unspent nuclear fuel rods amounts to about 7000 Hiroshima atomic bombs, and the possibility of it causing a nuclear fission chain reaction persists for one million years.

In addition to the above-mentioned dangers, there exists a cooling pool for spent nuclear fuel rods on the third floor of each building of the three units. The total of the radioactive materials in the three pools amounts to the equivalent of 16,000 Hiroshima atomic bombs. They are submersed in water in order to confine radioactivity. For 300 years at least, they make us dread mega-earthquakes and the associated collapse of the buildings that could take place at any moment.

## 2. My impressions

**The DNA of Japan as a nation has been damaged by the nuclear accident.** I have been asserting that nuclear reactors are no less dangerous than nuclear weapons, but it is more correct to say that nuclear reactors are more dangerous than nuclear weapons.



**The nuclear accident has obliged many residents of Fukushima to abandon their native places.** It has contaminated Japan’s invaluable soil with radioactivity and has brought about a situation that obliges the relevant residents to abandon forever their living and farming land.

**The ongoing radioactive contamination of the sea with no prospect for a solution is dishonoring Japan, being criticized as harming the global environment. In spite of all this, attempts are shamefully being made to hide Fukushima.**

The Tokyo Olympic Games, the Senkaku Islands problem, the Takeshima issue, all these are just out of the question.

**Natural Solutions Comments:**

We salute Amb. Murata for being a Truth Speaker. With the North American Pacific Fisheries being “closed” by government authority\*; with the horrific die-offs of Pacific fish and aquatic mammals, such as the Dolphins, we are seeing the Horrors of Fukushima spreading across the world. It is not just the DNA of the people of Japan that is at risk, as Murata-san notes, it is the genetic integrity of all peoples and species at risk.

Dr. Rima has termed this condition “Genomic Disruption Syndrome” and the toxic impact of nuclear disasters is just one of its causes.
